



FRAMEWORK AGREEMENT

Between UNIVERSITY OF MONASTIR, TUNISIA

And PERM STATE UNIVERSITY, RUSSIA

Recognizing the importance of an international experience in the education and development of their students and professors, wishing to provide their students and teachers with opportunities for studying and working in an international environment,

The parties:

University of Monastir, Tunisia situated in Taher Hadded road (B.P 56) Monastir 5000 Tunisia, represented by its President Prof. Hédi BEL HADJ SALAH,

And

Perm State University situated in 15 Bukireva Street (B.P. 614068) Perm Russia, represented by its Acting Rector Dr. Igor Germanov.

The parties enter into this Framework Agreement for the creation of a partnership between the two universities. The parties hereto agree as follows

1. Objectives

University of Monastir and Perm State University acknowledge that an international experience for students, teachers, researchers and administrative personnel is integral in the positioning of a business school in the global economy. As such the parties agree to work together in the following areas of cooperation:

- a. Exchange of students,
- b. Exchange of teachers,
- c. Exchange of administrative personnel,
- d. Joint research projects, conferences, and implementation,
- e. Double degree and joint program development and implementation,
- f. Training of trainers
- g. Joint supervision of doctoral theses
- h. Other agreed activities aimed at developing the relationship between the University of Monastir and Perm State University.



2. Student Exchange

It is agreed that the partnership shall commence with student exchange between the two institutions. This shall be a subject to separate appendices or specific agreements between the parties. These appendices or specific agreements shall be submitted to the supervising authorities for an opinion before signing.

The two institutions seek to explore opportunities for scholarships granted to foreign students.

3. Formal Agreements

It is acknowledged that there shall be separate Agreements for each of the items listed above which shall be included as appendices or specific agreements to this Memorandum of Understanding. These appendices or specific agreements shall be submitted to the Ministry for an opinion before signing. The parties agree to make all reasonable efforts to work together in this partnership to advance the ties between University of Monastir and Perm State University.

4. Conflicts

Any difference in the understanding of this agreement or in its execution will be resolved between the two parties by amicable settlement or diplomatic ways.

In case of disagreement, the dispute will be resolved through the constitution of a committee made up of the two parties in order to decide on the dispute.

In virtue of this agreement, both parties shall adhere to the proposals of the committee.

5. Effective Dates

This Agreement shall be for a duration of five (05) years commencing on the date when it was signed by the latter party. Either party to this Agreement may rescind the above mentioned Agreement by providing twelve (12) months notice of their intention to terminate the Agreement. Any termination shall take into account students, teachers, and other personnel already involved in any activities under this Agreement and the above mentioned appendices and specific agreements.

The end of application of this agreement has no effect on projects and activities already initiated before its cancellation.
